

**Model acknowledgement (release)**

- 1. The person or persons, being signatories to the present Release, enter into an agreement that:
  - 1.1 The Model acknowledges that he/she is of legal age and is of right to sign the Release on his / her own behalf and in compliance with the laws in force in the territory of the Model's residence;
  - 1.2 The person or persons, being signatories to the present Release, have carefully read the Release and by their signature confirm their acceptance of the document content and all possible consequences;
  - 1.3 The present Release is untimely applicable to the Model, her / his heirs, executors, legal representatives and successors.

2. All international rights, name of the Image and all related materials (including authorship and all other intellectual property) belong to the Photographer or to the person, the Photographer transfers them to.

3. The Photographer has an irrevocable right (which can be licensed, transferred and granted for use as the Photographer deems appropriate) to use, publish, reproduce, rework, display publicly, both digitally and in any other form, known at present or invented later on, the Images in any form, without restrictions, using them in whole or in fragments, in original or reworked form, without restrictions on the accompanying text and visual design, linked with the Model name, or any other fictitious name, or without it, for illustrations, advertising, public use in the fields of art, trade, publication or any other commercial use. The model also agrees to the use of any text, audio, sound, action, video, program, effect, etc. , that may one way or another be associated with his/her Image, and waives any rights that may ever belong to him/her, related to the use of the Images, covered by the present Release. The Photographer will use reasonable endeavours to ensure that the Images are not used for any pornographic, obscene, discrediting or slanderous purposes, based on the consent of the Model.

4. The Model permanently releases the Photographer and each of the Permitted Parties, and anyone, acting by the right, granted by the license or permission of the Photographer or the Permitted Parties, from any liability or expense that may be the result of:

- image blurring or visual distortion/alteration;
- use in context with something or in a composition (intentional or not) that may assist creation of an image or subsequent uses, indicated in the present Release,
- charges of defamation, invasion of privacy, violation of publicity or other forms of ownership.
